Raise money for SPS just by shopping with gift cards for everyday purchases like food, clothing and entertainment. Each PANTHER PERKS SCRIP gift card you buy earns a rebate for St. Paul's School Home & School Association.
PANTHER PERKS SCRIP is the powerful, "no-selling" fundraiser.

Q. How does Panther Perks SCRIP work?

A. When you access Panther Perks SCRIP, your family earns money for St. Paul's School just by making your regular household purchases. But instead of paying with cash or credit, you use prepaid gift cards from your favorite and most trusted retailers. The gift cards are offered to SPS at a discounted price – you pay and get to spend the full face value, while SPS is rewarded with the difference.

Q. What's the catch?

A. The catch – if there is one – is that families need to plan ahead a little and do their normal shopping with gift cards.

Q. How do I purchase Panther Perks SCRIP?

A. Panther Perks can be purchased each Saturday and Sunday between masses. During the school year we also offer TURN-IN TUESDAY – just send your order form into school by 8:30AM and most orders are filled the same day. Any IOUs are received by Friday of the same week.

Q. What do all those numbers on the order form mean?

A. Each retailer offers a specific denomination of gift cards available and the percentage discount which is SPS profit. For example, for each a \$25 Gap/Old Navy gift card, SPS earns 14% or \$3.50. Some retailers "pay" more than others, but every penny truly counts!

Q. Does it really add up?

A. By simply planning ahead on everyday purchases like groceries, gas, restaurants, clothes, entertainment and home repair, the average family can earn at least \$11 a week for SPS! That modest number adds up quickly - over \$500 a year raised by an average family is not unusual.
