Dear Parents:

Thank you for choosing to send your children to St. Paul the Apostle Catholic School. Once again we need to count our prospective students for next year. I cannot stress enough how important it is that you complete and return this letter to the school office as soon as possible – **but no later than Friday, February 17.** The Registration fee is \$100 per student. **If you pay prior to February 17, the fee is discounted to \$75 per child.** You will only need one form per family for children who are currently in grades K-7, but please list each student separately. Please contact John Heidemann at 322-7994 if you have tuition delinquency, which must be resolved before students are allowed to enroll in a subsequent year.

**If you have a child who is currently in preschool and entering Kindergarten in the school year 2012-2013 or a child who will be attending preschool next year, please do not include them on this sheet.**

Our Kindergarten and Preschool Round Up are as follows:

Students entering **Kindergarten in 2012-2013** must attend Kindergarten Round Up on

- Tuesday, February 21 either from 9:00 AM – 10:30 AM or from 1:00 PM– 2:30 PM.

If you have a child who will be in **Preschool** next year, you will need to attend Preschool Round Up on Thursday, February 23.

- For 3-year-old preschool, you may drop into the Early Learning Center between 9:00 AM and 11:00 AM.
- For 4-year-old preschool, you may drop into the Early Learning Center from 10:00 AM – 1:00 PM.
- For Pre-K, you may drop into the Early Learning Center from 12:00 PM – 2:00PM.
- If you cannot attend one of these round ups, please contact the school office to arrange a time to pre-register your child(ren).

If you know of anyone - friend, relative or neighbor - who is thinking about St. Paul's for next year, please provide that information.

Policy Statement on Tuition: In all Diocese of Davenport schools, in particular at St. Paul the Apostle School, all expenses for religious instruction are paid from the contributions of the respective parish/parishes which support the elementary or secondary school(s). No part of the tuition or fees paid by parents or students, unless specifically itemized as an expense related to religious instruction, shall be deemed as tuition or fees for religious instruction. All tuition and textbook charges paid directly by parents and/or students are appropriate tuition tax deduction/credit expenditures.
